

ADDENDUM No. 1 TO LICENCE AGREEMENT

THIS ADDENDUM to the Licence Agreement dated 24th March 2021, is made on 21st July 2021

Between:

- (1) INFORMA UK LIMITED trading as TAYLOR & FRANCIS GROUP, a company registered in England and Wales with company number 01072954 whose registered office is at 5 Howick Place, London, SW1P 1WG, United Kingdom and whose principal place of business is 4 Park Square, Milton Park, Abingdon, Oxfordshire, OX14 4RN, United Kingdom (the "Publisher", which includes the Publisher's administrators, assigns and successors in business, as may be appropriate); and
- (2) **NATIONAL UNIVERSITY OF IRELAND, MAYNOOTH, whose registered address is** IReL, Maynooth University Library, Co. Kildare, W23 VP22, Ireland for and on behalf of and duly authorised by the Institutions (the Organisation)

each a "Party" and together the "Parties".

BACKGROUND

- (A) The Publisher entered into a Licence Agreement with National University of Ireland, Maynooth dated 24th March 2021 under which the Publisher made (i) rights of access to and use of licensed materials published by the Publisher; and (ii) rights to publish open access, available to the Institutions on its licence terms (the "Agreement", such definition including any subsequent amendments to that agreement agreed in writing by the Parties).
- (B) The Publisher has offered, and the Organisation (on behalf of itself and as agent for the Institutions) wishes to accept, an extension to the Publication Cap granted under the Agreement
- (C) The Parties now wish to amend the Agreement to include the terms set out in this Addendum.Definitions used in the Agreement shall apply to this Addendum, unless otherwise defined.

AGREED TERMS

- 1. In consideration of the mutual promises and other value consideration set forth herein, the Parties hereby agree that, as from the date of this Addendum:
 - 1.1 Once the Publication Cap has been reached in the 2021 Calendar Year, the



Organisation shall pay an additional €549,316 (five-hundred and forty-nine thousand and three-hundred and sixteen euros) (the "**Extended Publication Cap Funds**") to the Publisher for an extended Publication Cap under clause 10 of the Agreement.

- 1.2 The Extended Publication Cap Funds shall be allocated as follows:
 - 1.2.1 €487,935 shall be allocated to Open Select journals (four hundred and eightyseven thousand and nine-hundred and thirty-five euros); and
 - 1.2.2 €61,381 (sixty-one thousand and three-hundred and eighty-one euros) shall be allocated to Full Gold OA journals.
- 1.3 The Publisher shall apply a discount to the Article Publishing Charge of:
 - 1.3.1 twenty five percent (25%) for Open Access Articles published in an Open Select journal; and
 - 1.3.2 fifteen percent (15%) for Open Access Articles published in a Full Gold OA journal,

where the Article Publishing Charge is being paid for by the Extended Publication Cap Funds only.

- 1.4 Any unused Extended Publication Cap Funds in the 2021 Calendar Year shall be carried over to be used in the following two subsequent Calendar Years (2022 and 2023) during the Initial Term. Any Extended Publication Cap Funds that remain unused by the 2024 Calendar Year shall be treated as lost and the Publisher shall have no obligation to the Organisation in relation to them.
- 1.5 Any Article Publishing Charges relating to a Qualifying Article that is not eligible for publication under the Extended Publication Cap Funds for any reason shall be paid for by the author or their funder in the usual way in accordance with the terms of that journal or platform. This shall include any Premium APCs that are not eligible to be included in the Publication Cap under the Agreement.
- 2. All other terms and conditions of the Agreement shall remain in full force and effect.
- 3. This Addendum and any matters relating to this Addendum shall be governed by and construed in accordance with the laws of England. The parties submit and agree to the exclusive jurisdiction of the English Courts.
